Donations Helping Ukrainians Settle in B.C.


As Ukrainians leave their home in search of safety, many come to B.C. with few resources. Basic needs such as housing and purchasing essentials remain key concerns for their settlement in communities around the province.

Donations have been a key way in which Canadians have been providing help, with gift cards being one way in which businesses have been supporting displaced Ukrainians. As a province-wide association, AMSSA has been facilitating the distribution of corporate donations to regional focal points.

Thanks to donors such as Loblaws, Marks, Sports Chek and Canadian Tire, more than 500 gift cards have been provided to B.C. totalling over \$38,000. These donations have been distributed to service providers who direct donations according to community needs.

Gift cards help newly arrived families and individuals to purchase the most needed items and basic necessities such as groceries, clothing, home essentials and furniture, school supplies and child/infant essentials.

More Health Benefits Announced for Displaced Ukrainians

In April 2022, the Province of B.C. extended Medical Services Plan (MSP) coverage and also waived the three month waiting period to all newcomers arriving in B.C. with a Canada Ukraine Authorization for Emergency Travel visa (CUAET) to help ensure immediate access to health services. As the Province of B.C. looks for more ways to support displaced Ukrainians, the Province has recently announced two more measures to support access to health services:

Prescription costs

Ukrainians arriving under CUAET can now receive coverage for 100% of eligible costs under PharmaCare's Plan C for one year. Plan C coverage is automatic for those with a CUAET visa and have enrolled in MSP. For those who have arrived under CUAET and do not have MSP coverage yet, Emergency drug coverage is available, but only if the prescriber completes the Emergency BC PharmaCare Coverage for Ukrainian Arrivals Form.

Medical Diagnostic Testing costs

Ukrainians arriving under CUAET will now have the costs of the federally mandated medical diagnostic testing managed by the Province of B.C.'s Ministry of Health, meaning that they will not be billed for this service. The requirement is that they must have CUAET documentation and have enrolled in MSP. In addition, these costs can be reimbursed if already paid by filling out a request for reimbursement.

It is strongly encouraged that any Ukrainian arriving under CUAET to B.C. enroll in the Province of B.C.'s Medical Services Plan as soon as possible. This will help ensure that health services are accessible, and that they would be eligible to receive possible future health supports as they are made available.
